- **Strain on electrical grid**, could use more power than our entire city
- **Energy & water prices will increase**
- **24/7 light & noise pollution** that causes health issues and affects migratory birds
- **Carbon emissions & poor air quality**
- **Massive land use**, little benefit for residents
- **Little job creation**, only 20 permanent jobs
- **Too close to our homes**, especially across the river
